
To all of Charlie's and my family and friends: I apologize for the long delay in sending the attached information. It has been difficult for many reasons and circumstances. However, since it has been a year, I feel that I must finally let you know about the greatest loss of my life. Charlie fell and broke his hip on March 6, 2020, and had surgery. I stayed with him until the COVID-19 lockdown on March 11th. After that, he got an infection and had other complications. We could not see him again until they brought him back to our residence in Fredericksburg, Virginia, on April 28th, to be with our immediate family until May 5th, a week later.

Charlie was born in Wichita, KS. He attended school in and lived in Augusta, KS; got his bachelor's degree in Elementary and Secondary Education at Kansas State Teacher's College in Emporia, KS and his master's degree in Psychology from Pepperdine University. He taught Sixth Grade and Assisted Coaching Junior high track, football, and basketball at Douglas, KS.

Then he joined the US Air Force and made it into a 24 ½ year career as a pilot and Instructor pilot. He flew T-37's. T-38's. F-111A's. F-111D's. F-111F's. and EF-111's. He loved flying and got to see many places. including. Laredo AFB. TX, Perrin AFB. TX, Nellis AFB. NV, Cannon AFB. NM, Lakenheath AFB. UK, Mtn. Home AFB. ID. Izmir Turkey (NATO). Eglin AFB. FL. Thailand. Hawaii, Philippine's. Italy. Spain and others. After his retirement from the Air Force, Charlie taught elementary physical education at Oak Hill and Cherokee Elementary Schools on Eglin AFB. FL.

He had many hobbies and interests, including, sports, boating, fishing, scuba diving, rock hunting and lapidary work, metal detecting, photography, finding and collecting artifacts, gardening, biking, hiking, snow skiing, rollerblading, traveling, camping, and above all spending time with family and friends.

Angela Dawn Gray and Kurt Alan Rummell: his son in-law, Bret Christopher Gray; granddaughters, Delaney Barrett Gray, Darby Rhyen Gray.
